DHIVA:	Members of Dietitians in HIV and AIDS
HIVPA:	Members of the HIV Pharmacy Association
NHIVNA:	Members of the National HIV Nurses Association
RHIVA:	Members of the Rehabilitation and HIV Association
UK-CAB:	Members of the UK Community Advisory Board

3. The annual subscription is payable in advance on or before 1 January in each year and members whose subscription remains unpaid by 28 February following will be regarded as in arrears and cease to be members of the Association.
