INTRODUCTION

HIV in Primary Care – all you need to know

We are delighted to welcome you on behalf of the Royal College of General Practitioners and the British HIV Association to this conference on HIV in Primary Care, bringing together general practitioners, practice nurses, HIV clinicians and other professionals working in primary and secondary care.

General practitioners and primary care teams have increasingly important roles to play in the diagnosis, treatment and care of their patients who have HIV, as well as those who are at risk of acquiring the infection. For people with HIV, who are diagnosed in time, and can both access and engage with treatment and care, the long-term outlook is optimistic. In these settings many of the principles of chronic condition management are increasingly relevant for the best care and outcomes for people with HIV.

Yet, in 2012, up to a quarter of people living with HIV in the UK are unaware of their HIV status. By increasing HIV testing and diagnosis we can reduce late presentation and undiagnosed HIV and, in so doing, not only improve the health of people with HIV but also reduce the potential for others to acquire HIV.

The programme will be delivered by partnerships of general practitioners and HIV clinicians all of whom have significant experience in the treatment and care of people with HIV. Many of the organising team are involved with the RCGP Sex, Drugs and HIV Working Group and the BHIVA Primary Care Working Group.

The programme consists of lectures reviewing the evidence for recommendations, and will be illustrated by practical clinical examples. Current best practice and examples of quality of care initiatives will be shared and recent advances, together with likely future developments in diagnosis, treatment and prevention of HIV, will be explored. There will be a number of expert panel discussions together with smaller seminars, giving opportunities for delegates to pose questions and discuss a wide range of HIV-related issues.

We would like to thank all our speakers and chairs for giving of their time to speak and share their expertise. We also extend our thanks to our sponsors, whose generosity has allowed us to deliver the programme without cost to delegates.

We very much hope you will enjoy the conference and find it relevant to both your educational and practical needs.

BIOGRAPHIES

Jane Anderson is based at Homerton University Hospital NHS Foundation Trust in East London. Professor Anderson's clinical and research interests focus on HIV in diverse populations in the UK. She is working with primary care colleagues on HIV testing in general practice. Jane is Chair of the British HIV Association (2011–2014).

David Asboe studied medicine at Otago University, New Zealand and completed specialist training in Genitourinary Medicine at St Thomas' Hospital London in 1996. He is a consultant in HIV medicine and sexual health at Chelsea and Westminster Hospital, London. His special interests are antiretroviral resistance, sexual health of HIV-positive persons, and HIV and ageing. He is the convenor of the Diploma in HIV Medicine exam run by the Worshipful Society of Apothecaries, and is a trustee on the Executive Committee of the British HIV Association.

Yusef Azad is Director of Policy and Campaigns at NAT (the National AIDS Trust), which he joined in 2004. He has worked on all areas of HIV policy in the UK, and has paid particular attention to the criminalisation of HIV transmission, migration issues, HIV prevention and testing. From 2008 to 2011 he was co-Chair of the European Commission's HIV/AIDS Civil Society Forum. He was previously a House of Commons clerk.

Garry Brough has worked in HIV peer support since co-founding the Bloomsbury Patients Network in 1999. He was co-ordinator of the YMCA Positive Health Programme and Patient Representative at the Bloomsbury Clinic before becoming an HIV Health Trainer at Terrence Higgins Trust, where he is now Membership and Involvement Officer. He has been involved in various BHIVA Committees and working groups and is currently the Community Representative on the BHIVA Executive Board.

Will Ford-Young is a full-time GP partner and GP trainer in Macclesfield, Cheshire in a medium-sized practice covering a very mixed demography of patients. Until recently he has also worked in GUM clinics including a specialist GUM clinic in Manchester for men who have sex with men. During his 24-year career as a GP he has developed an interest in the role of the GP in HIV as a long-term condition, as well as awareness raising for HIV testing in general practice. He has been a member of the RCGP Group for Sex, Drugs & HIV for many years and was the GP representative on the previous government's Independant Advisory Group for Sexual Health and HIV. Other interests within general practice include management of patients with substance misuse problems, hepatitis C, and dementia care.

Philippa James is a GP partner in inner city Manchester. She has previously worked in Contraception and Sexual Health Services and was Clinical Lead at Brook in Manchester for 2 years. She is the HIV Lead of the Sex, Drugs and HIV Group at the RCGP. Dr James also sits on the Central Manchester CCG Board.

Ranjababu (Babu) Kulasegaram is a Consultant in HIV/GU Medicine at Guy's and St Thomas' NHS Foundation Trust and leads the HIV Treatment Advice Clinic with special interests in HIV/hepatitis, haemophilia/HIV infection, HIV/brain and HIV inpatient management. He is Training Programme Director for the SpRs and is committed to enhancing BHIVA's educational activities through his involvement as a member of the BHIVA Educational and Scientific Subcommittee and E-Learning Working Group. He is on the examining board for the Diploma in HIV Medicine. Babu is also Chair of the BHIVA Hepatitis Society and an author of the HIV/hepatitis 2010 guidelines.

Richard Ma is a GP principal in London. He has over 10 years' experience in sexual health, having trained at King's College Hospital, Mortimer Market and Margaret Pyke Centres. More recently, he managed the sexual health enhanced services for Islington PCT. He is also a member of the RCGP Sex, Drugs & HIV Group, GP Sexual Health Champion for NHS London and a half-time doctorate student at the London School of Hygiene and Tropical Medicine.

BIOGRAPHIES

Philippa Matthews is a salaried GP at Killick Street Health Centre in King's Cross. Past work has included general practice in Birmingham, work in a clinic for street-based sex workers, QOF lead for sexual health and co-editing the sexual health module of e-GP. She is currently developing a website to support GP HIV testing with the sexual health charity, MEDFASH. She is an editor and author for the Handbook of Sexual Health in Primary Care and for the MEDFASH booklet 'HIV in primary care' (2011 editions). She is a clinical consultant and education lead for Sexual Health In Practice (SHIP). SHIP is a multifaceted educational intervention that has been shown to increase general practice HIV testing rates in very high prevalence areas by over 350%. Philippa is an expert clinical reviewer for Nina Murphy Associates.

Steve Mowle is a GP Principal at the Hetherington Group Practice, an inner city practice in the heart of the Borough of Lambeth, London. He has held a variety of different educational leadership roles within the London Deanery and King's College, London. Currently he is a Patch Associate Director with responsibility for Inner South West London and also has Pan-London responsibility for Post CCT GP training. He has a keen interest in Medical Education and Training and was a member of the RCGP First Five Working Group and a founding member of the RCGP Quality Management and Training Standards Committee. Steve has been an active member of his local faculty board and as its Chair was a founding member of RCGP London. He has also been the lead on the International Committee for the formation and development of the Junior International Committee which has proved to be a major success. As Vice Chair, Steve will be the lead for the 2013 Conference in Harrogate, lead officer for the Patient Partnership Group and lead for the Centre for Commissioning.

Angelina Namiba has over 13 years' experience of working in the HIV sector on initiatives ranging from providing one-to-one support to people living with HIV: managing service provision to facilitating, promoting and advocating for the involvement of women living with HIV in informing national strategy and policy. She co-authored the report Primary Care Access: how General Practice can better respond to the needs of people living with HIV.

Anthony Nardone has nearly 20 years' experience as an infectious disease epidemiologist, mostly in the field of HIV and STI control and prevention. Since 2007, Anthony has been head of Sexual Health Promotion at the Health Protection Agency. His interests include the evaluation of public health interventions for the control and prevention of HIV and STIs, including the promotion of HIV testing.

Ewen Stewart is Clinical Lead Viral Hepatitis MCN, NHS Lothian and General Practitioner, Lothian. Dr Stewart has had an interest in blood-borne viruses since 1989. He has worked for NHS Lothian as Primary Care Facilitator for blood-borne viruses since 1999 and as Clinical Lead for the Viral Hepatitis MCN since 2009. He is Chair of the Royal College of General Practitioners' Sex, Drugs and HIV Task Group and a member of EAGA, the expert advisory group on AIDS for the UK Chief Medical Officers.

Jason Warriner has worked for Terrence Higgins Trust since August 2009 as Clinical Director/Service Quality and Governance Director. Prior to working for Terrence Higgins Trust, Jason has held a number of senior nursing positions in the NHS. He is a member of the Prime Minister's Nursing and Care Quality Forum. He has worked in the field of HIV and sexual health for a number of years in the UK and also has experience of working on Children's HIV projects in South Africa.
