



Introduction




- Community-led survey of 1,576 people living with HIV throughout the UK
- Recruited from across 120 cross sector community organisations and 47 NHS HIV clinics
- Anonymous online survey focusing on lived experiences in past 12 months
- A range of social and healthcare settings including dental practices
- Analyses conducted at Public Health England with dentists and other oral health professionals and community engagement throughout





Who took part?











There were more men than women compared to national PHE data

Aims




- •Describe the current experiences of people living with HIV in the UK who are currently attending dental services
- Examine the factors associated with avoiding dental care and treatment

Methods

- •Descriptive analysis on 1,528 (97%) participants who completed health care section
- •Univariate and multivariate logistic regression analyses to describe the experiences of people living with HIV attending dental practices and identify the factors associated with self-avoidance of seeking needed dental care

Awareness of HIV status






HIV disclosure and stigma

Conclusions



- •In 2015 people living with HIV reported experiences of stigma and discrimination in the dental services in the UK
- •Over a third did not feel in control over the disclosure of their HIV status to dentist or supported upon disclosure
- Just half of PLHIV had disclosed their HIV status to dental staff
- •There was a strong relationship between experiences of HIV related discrimination and avoidance of future dental care

Thoughts



 Relevant educational tools targeting the dental team should be developed to address HIV related stigma and discrimination in this setting
